The Faculty of Medicine at the University of Tübingen invites applications for a position at the Department of Diabetology, Endocrinology and Nephrology as a

Professor (W3) of Clinical Metabolism and Obesity Research

at the next possible date.

The professorship is initially limited to 5 years at the Institute for Diabetes Research und Metabolic Diseases of the Helmholtz Zentrum München at the University Tübingen and can be extended or converted to a permanent position (tenure track) after a positive evaluation and the availability of required funding.

We are looking for a Clinician Scientist. The granting of an application within a Helmholtz Young Investigator Group of the Helmholtz Association is a prerequisite for a successful application.

The requirements for a successful application are:

- Outstanding research performance in clinical and preclinical research at the microbiome/metabolism interface
- Stays abroad in world leading laboratories on microbiom / metabolism
- Specialist for internal medicine with proven expertise in the treatment of patients with obesity and diabetes as well as endocrinological patients
- Proven experience as Clinician Scientist and guidance of junior staff in this area
- International publications and independently outstanding third-party funds
- outstandingly evaluated experience and commitment to teaching, especially with regard to innovative curricula of the degree programs of the Faculty of Medicine, as well as the co-design of courses, ideally proven by teaching awards

The professorship will be newly established to strengthen the research foci/topics on microbiome, metabolism, diabetology and obesity therapy of the Medical Faculty of the University of Tübingen. The candidate is expected to actively involve in the scientific priorities of the Faculty and University as well as in the University's cluster of excellence EXC2124 Controlling Microbes to Fight Infections (CMFI), e.g. by heading a CMFI junior research group. Participation in the teaching of the Faculty of Medicine is expected.

Required qualifications include a MD or equivalent international degree and postdoctoral qualifications equivalent to the requirements for tenure. This includes evidence of teaching effectiveness.

The University of Tübingen is particularly interested in increasing the number of women in research and teaching and therefore strongly encourages women candidates to apply. In line with its internationalization agenda, the university welcomes applications from

researchers outside Germany.

Applications from equally qualified candidates with disabilities will be given preference.
